#### **Activities and achievements**

The choir welcomed Tomislav Celeketic as its new conductor. The main work in the Summer concert was Mozart's Coronation Mass with soloists drawn from the choir. There followed a number of shorter works, featuring students of Tom as well as works for the full choir. The choir was invited to sing at the village Coronation lunch in May and sang a selection of works they had been rehearsing for the summer concert. During the summer, a short course of five sessions was taken by Tom to improve vocal technique. The Christmas concert consisted of a number of short pieces for choir with carols for audience participation. Two soloists from the choir sang the Cat Duet by Rossini which was very well received. We are grateful for Tom's success in improving the quality of the choir's singing.

### Trustees' remuneration and expenses

The Trustees did not receive any remuneration or expenses during the year in their capacity as Trustees. An amount of £2149 was reimbursed to Trustees during the year for goods and services paid by them.
